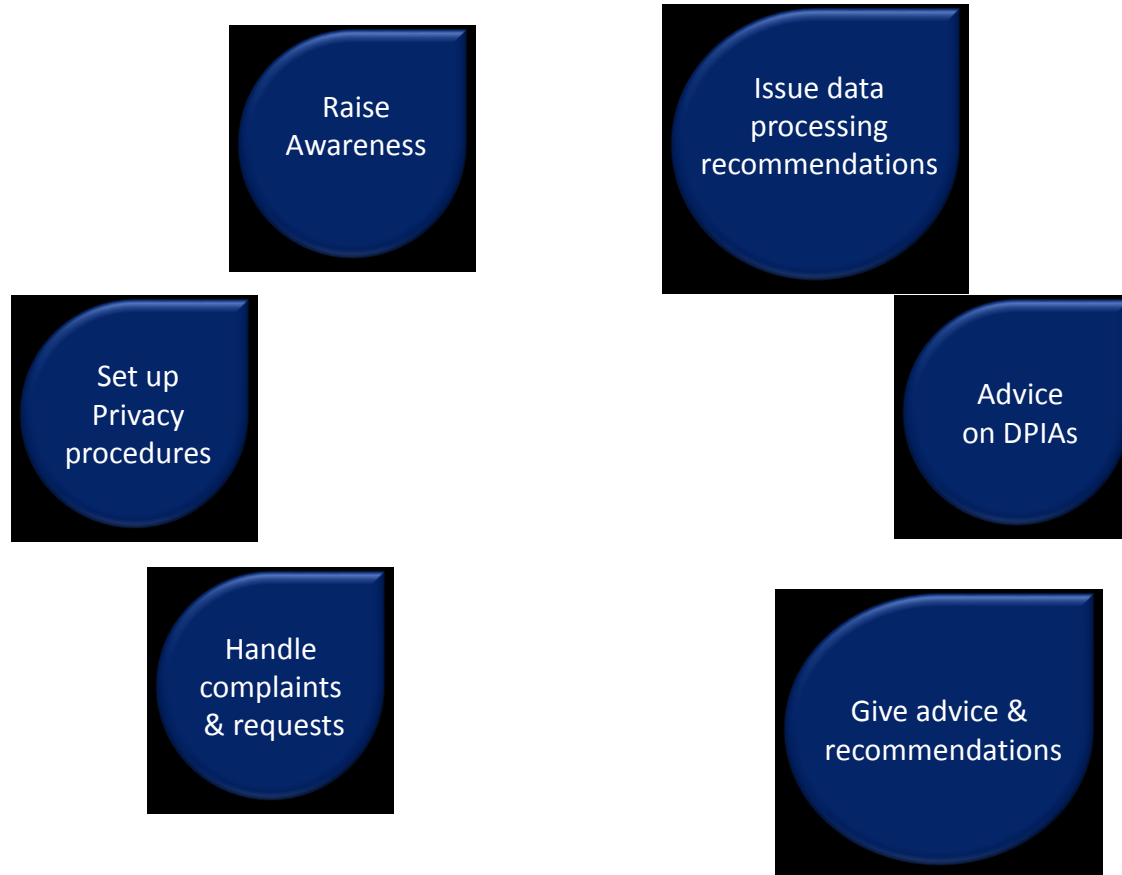

Provide sufficient time & resources for the DPO to carry out tasks effectively

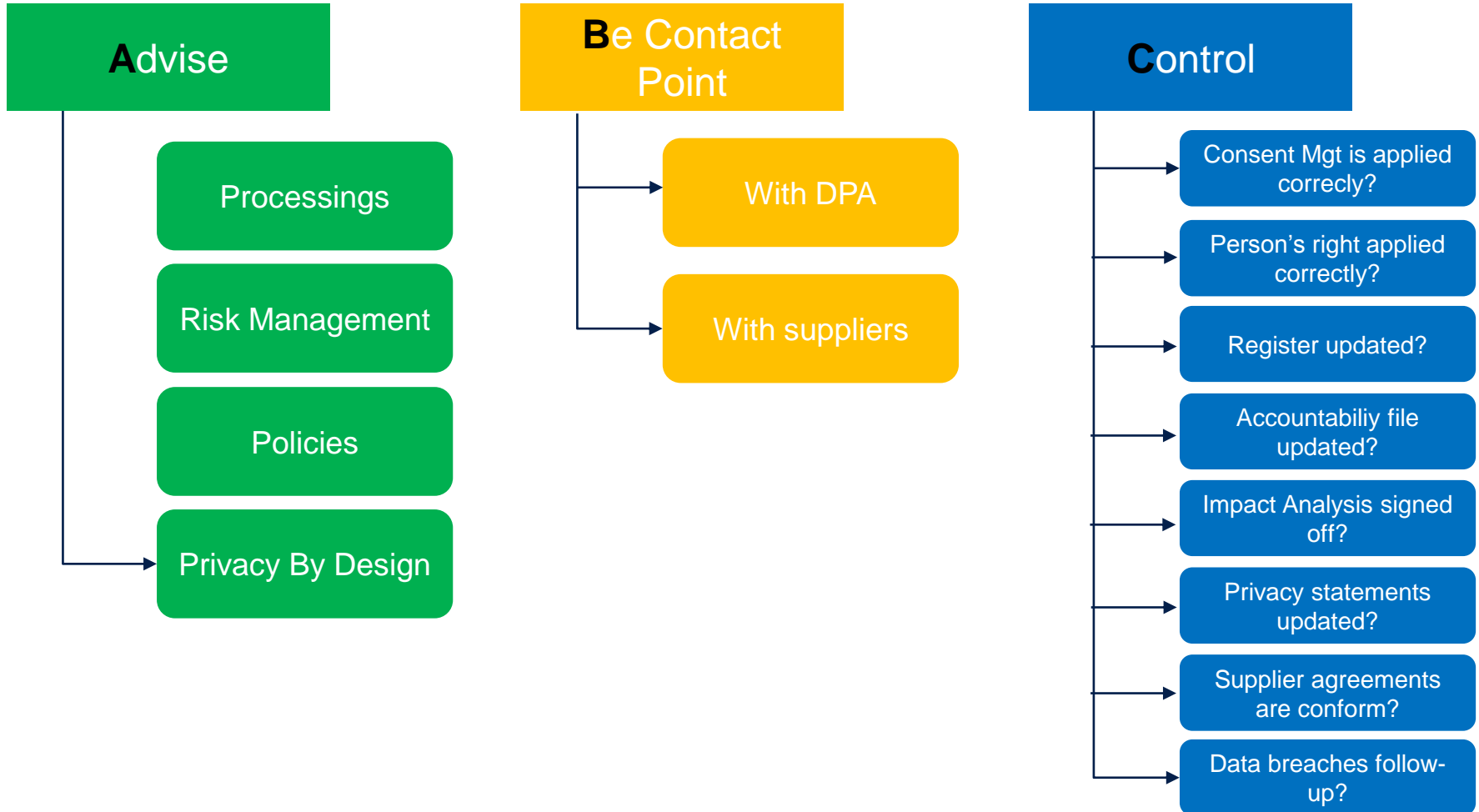

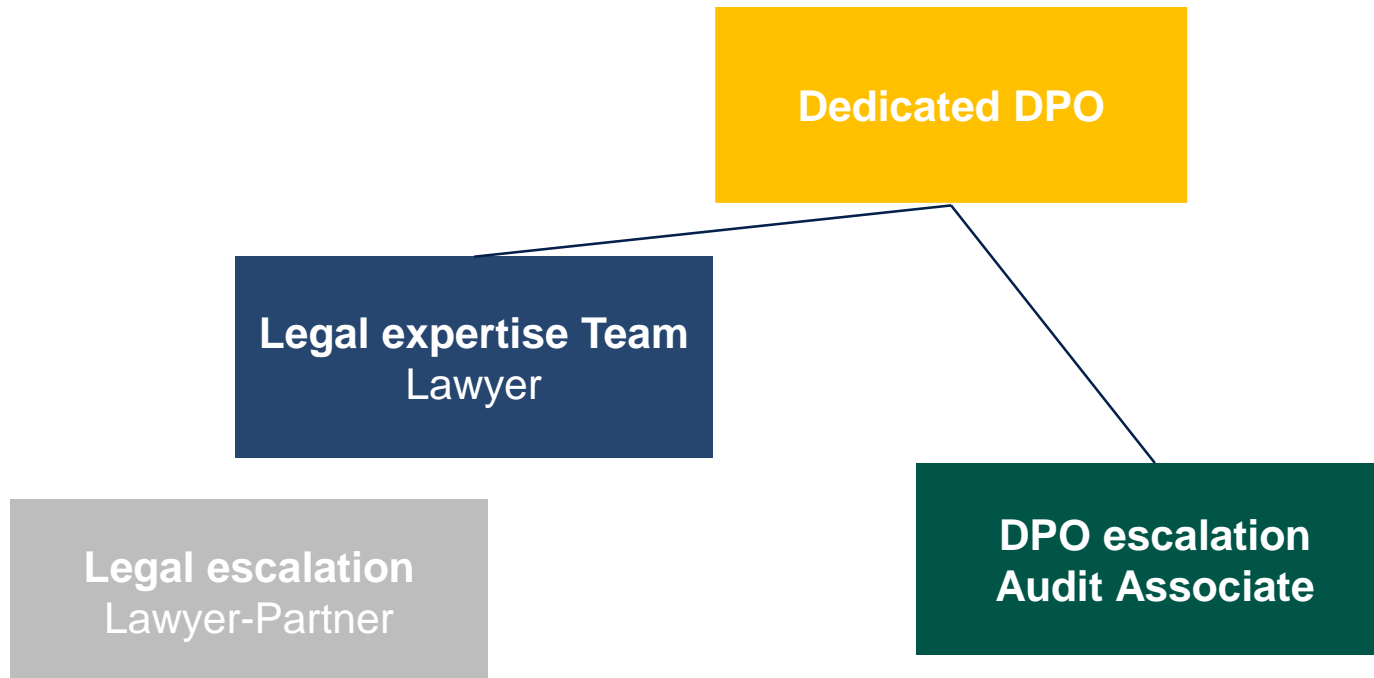
